STATUTORY TASKS of The Research Centre for Cultivar Testing (COBORU) (in relation to PBR)

- Administration of plant variety protection system in Poland
- Keeping the register of varieties protected by PBR
- Preparation of guidelines for DUS tests on the basis of the UPOV guidelines and the CPVO protocols
- Carring out of DUS tests for purpose of the variety listing and/or granting of the PBR
- Publication of the Gazette for Plant Breeders Rights and National List (Diariusz)

STATUTORY TASKS of COBORU (in relation to PBR)

- Administration of fees (application fee, examination fee, annual renewal fees etc.)
- Examination as to formal requirements, filing date,
- Examination of the application as to substance,
- Technical examination of a variety

STATUTORY TASKS of COBORU (in relation to PBR)

- Co-operation with the International Union for the Protection of New Varieties of Plants (UPOV) in the field of DUS examination and implementation of UPOV Convention on the Polish territory
- Co-operation with the registration authorities in the EU Member States and with the Community Plant Variety Office (CPVO)
- Co-operation with organizatios and institutions in the field of plant breeding and seed production
- Implementation of other tasks arising from The Law on the Legal Protection of Plant Variety of Plant Varieties and The Law on the Research Center for Cultivar Testing

Technical Examination of the Variety

- To verify that the variety belongs to the stated botanical taxon,
- To establish that the variety is distinct, uniform and stable (DUS testing)
- To prepare the Official description of the variety

Conditions for granting of PBR

The breeder 's rights shall be granted when the variety is:

- New,
- Distinct,
- Uniform, Stable.

Conditions for granting of PBR

- Other conditions:
- Variety denomination in accordance with the provision of Art.20 of UPOV Convention,1991
- The applicant complies with the formalities provided for by the Law
- Application has been filed
- The required fee paid

System of the DUS Testing

- DUS tests conducted within the COBORU testing network
- DUS tests conducted in co-operation
- Takeover of the DUS reports

Granting of PBR Certificates

The decision concerning the granting of PBR is taken by the COBORU Director General after the opinion of the Internal Commission on Granting Plant Breeder's Rights consisting of:

- COBORU Deputy Director for Experimental Affairs,
- Head of DUS Testing Department,
- Head of Listing and PBR Office,
- Lawyer,
- Staff responsible for different crop groups

Regulations and Documents on PBR

- The Law on PBR
- The Law about COBORU
- The Decree of Minister on confirment of the statute on COBORU
- The Decree of Minister on Application of Varieties for the grant of PBR and concerning the official examination of varieties
- Decree of Minister on the registration fees and the protection fees

PBR Regulations and Documents

The Orders concerning:

- Documentation and the forms of documents
- The Species for which DUS tests are conducted according the CPVO protocols or the UPOV guidelines
- Agreements about the DUS test co-operation
- Minimal quantities and quality as well as terms of supply of seed material to the DUS tests

DUS arrangements

Growing trials, as a rule, conducted by COBORU, at one or two Experimental Stations for Variety Testing (SDOO), on the basis of:

- test protocols adopted by the CPVO AC
- UPOV test guidelines
- national protocols based on the UPOV guidelines

 For fruit plant varieties – subcontractor: Research Institute of Pomology and Floriculture in Skierniewice

DUS arrangements

No tests done by breeders

(c) COBORU can also take into account the results of growing tests which have already been carried out – purchasing of DUS reports

- *Harmonization of DUS testing in the Community listing system and PBR system*
- Additionally, some biochemical methods are used (e.g. electrophoresis)

Cooperation between Authorities TGP/5

- Bilateral agreements with: CZ, HU, SK
- Conducting of DUS tests for: CO, CPVO, ES, HR, LT, LV, NO, RO, SL
- DUS reports takeover (from other Authorities)

DUS reports takeover

 ✓ UPOV Request for Examination Results and UPOV Answer to the Request – TGP/5 Section 5

- Purchase of DUS reports from other countries without formal agreements
 e.g. Asparagus
- Agreed UPOV fee: 350 CHF or 240 EUR
- Grant of PBR title on the basis of the Report on Technical Examination
